Terms & Conditions: The OCC Special Reduced Deposit (OCCSRD) amount is only available to guests who book while onboard a current Windstar Cruise for a future sailing. The OCCSRD is based on the total Cruise Fare of the booking, within the range as displayed on the OCCSRD chart. Guests who decide to change or cancel their booking with an OCCSRD may do so without penalty, as long as the change/cancel is made 121 days or more prior to the sailing date. If a new booking is not made at time of change/cancel, the OCCSRD will remain on the original booking as a pending status in the name of the guests, and can be applied/used for a new booking with Windstar for up to two years. When guests change/cancel their booking inside 120 days from sailing date, normal Windstar Cruises booking terms and conditions apply and fees will be assessed against the OCCSRD and other amounts paid accordingly. OCCSRD amounts that are not applied to a valid booking after two years are eligible to be refunded to the guests in the form of a check from Windstar Cruises. Guests must contact Windstar and provide the original booking number which contains the OCCSRD and provide current address, email and telephone number in order for the OCCSRD refund to be processed. The savings percentage discounts are applied and calculated against the Cruise Fare portion of the booking only. Each savings percentage is calculated separately: The 5% Onboard Savings is applied first against the Cruise Fare; then the 5% Yacht Club Member Savings is applied against the adjusted Cruise Fare. The NDAs, taxes, fees and other amenity and booking elements are not eligible for the Onboard and Yacht Club Member Savings percentage discounts. Some promotional (discounted) Cruise Fares are NOT COMBINABLE with the Onboard and Yacht Club Member discounts. Please ask your Onboard Cruise Consultant for complete details. Cruise cabins and cruise fares are subject to availability at the time of booking. Cruise Fares are subject to change.
