

BEYOND ORDINARY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING.

SWEEPSTAKES ENTRY PERIOD: The Beyond Ordinary Sweepstakes (the "Sweepstakes") starts at 12:00:00 PM Eastern Time ("ET") on 1/2/20 and ends at 11:59:59 PM ET on 12/31/20.

ELIGIBILITY: Open to legal residents of the 50 United States, including the District of Columbia, age 21 and older at time of entry.
